


ORDINANCE NO. 18-11-01-80

AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF PERSONAL PROPERTY OF THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS

WHEREAS, the City of Le Roy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

WHEREAS, it has been determined by the Mayor and City Council of the City of Le Roy to dispose of the property listed on Exhibit A in the manner determined by the City Administrator to be in the best interest of the City; and

WHEREAS, the City of Le Roy is authorized by Section 11-76-4 of the Municipal Code to dispose of surplus personal property in any manner approved by ordinance.

WHEREAS, a majority of the corporate authorities now holding office at a regular meeting held at 7:00 p.m., on November 5, 2018, did make and aforesaid determination;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled:

SECTION ONE. The foregoing recitals are incorporated herein as findings of the Mayor and City Council of the City of Le Roy, Illinois.

SECTION TWO: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the Mayor and the City Council of the City of Le Roy find that the following described personal property in the attached Exhibit A, now owned by the City of Le Roy, is no longer necessary or useful to the City of Le Roy and the best interest of the City of Le Roy will be served by sale as instructed above.

SECTION THREE: Pursuant to Section 11-76-4, the City Administrator and/or his designees are hereby authorized and directed to sell the aforementioned personal property now owned by the City of Le Roy in accordance with the instructions set forth in this ordinance.

SECTION FOUR: The various provisions of this Ordinance are to be considered as severable, and if any part or portion of this Ordinance shall be held invalid by any Court of competent jurisdiction, such decision shall not affect the validity of the remaining provisions of this Ordinance.

SECTION FIVE: All prior Ordinance and Resolutions in conflict or inconsistent herewith are hereby expressly repealed only to the extent of such conflict or inconsistency.

SECTION SIX: This Ordinance shall be in full force and effect upon passage, approval and publication in pamphlet form as provided by law.
