

## ORDINANCE # 15-12-01-10

### AN ORDINANCE LEVYING TAXES FOR CORPORATE PURPOSES FOR THE FISCAL YEAR COMMENCING ON THE FIRST DAY OF MAY, 2016 AND ENDING ON THE THIRTIETH DAY OF APRIL, 2017 FOR THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS.

BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, Illinois as follows:

SECTION ONE: A property tax for the following sums of money, or as much thereof as may be authorized by law shall be levied to defray all expenses and liabilities of the City of Le Roy for the purposes specified against all taxable property in the City of Le Roy, Illinois, for the fiscal year commencing on the first day of May, 2016 and ending on the thirtieth day of April, 2017.

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE  
ALL COUNTIES EXCEPT COOK

I, the undersigned, hereby certify that I am the presiding officer of the City of LeRoy, Illinois, (Legal Name of Taxing District), and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check one of the choices below:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.


