

APPROPRIATION ORDINANCE NO. 60

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF LE ROY, MC LEAN COUNTY, ILLINOIS:

SECTION 1. That for the purpose of defraying all of the necessary expenses and liabilities of the City of Le Roy for the fiscal year commencing May 1, 1977 and ending April 30, 1978, the following sums or so much thereof as by law may be authorized be, and the same are hereby set aside and appropriated for the following purposes:

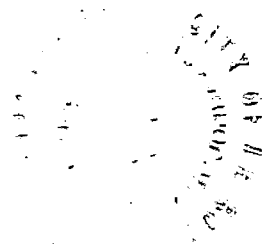
