

**ORDINANCE NO. 22-02-02-41**

**AN ORDINANCE PURSUANT TO TITLE EIGHT, CHAPTER FIVE,  
SECTION TWO OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS,  
SEWER SERVICE RATES AND CHARGES**

**WHEREAS**, the City of Le Roy, McLean County, Illinois is an Illinois municipal corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.*( hereinafter referred to as "CITY"); and

**WHEREAS**, the current sewer rates for the City are below water and sewer rates identified by the U.S. Bureau of Labor Statistics' Consumer Price Index; and

**WHEREAS**, the Mayor and City Council of the City of Le Roy have determined that it is necessary and beneficial for the citizens of the City of Le Roy to have access to clean water and efficient, effective removal and treatment of waste water; and

**WHEREAS**, the Mayor and City Council of the City of Le Roy have previously adopted an ordinance providing for increases of water and sewer rates to reflect the changes identified in the Consumer Price Index; and

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Le Roy, in lawful meeting assembled on Monday, February 7, 2022, as follows:

That pursuant to Title 8, Chapter 5, Section 2, Subsection D4, of the Municipal Code of the City of Le Roy, Illinois, the Mayor and City Council make the following changes to the City sewer rates:

**Section 1.** There shall be and there are hereby established a minimum charge and basic user rate for the use of and for service supplied by the wastewater facilities of the City. There shall be a minimum charge of eight dollars and ninety-one cents (\$8.91) per one month period to all users whose water consumption does not exceed one thousand (1,000) gallons per month. There shall be a basic user rate of eight dollars and ninety-one cents (\$8.91) per one thousand (1,000) gallons metered or adjusted in excess of one thousand (1,000) gallons per one-month period to all users who discharge normal strength wastes to the system. These charges are effective with the first water meter reading after June 1, 2022.

**Section 2.** This ordinance shall be in full force and effect following its passage and approval as required by law.
