ORDINANCE NO. 24-11-02-70

**AN ORDINANCE AMENDING SECTION 1-4-3 (B), SECTION 4-2-2-5.5
AND SECTION 4-2-2-6 OF THE CITY OF LE ROY CODE OF ORDINANCES -
IMPROPER DISPOSAL OF LANDSCAPE WASTE**

WHEREAS, the City of Le Roy has, pursuant to authority granted by the Illinois Municipal Code (65 ILCS 5/1-1-1 *et seq.*), enacted certain ordinances regulating the disposal of landscape waste materials at the designated landscape waste disposal site; and

WHEREAS, the City of Le Roy desires to amend the City Code regulating the disposal of landscape waste materials at the designated landscape waste disposal site and impose fines and establish minimum pay at City hall amounts for violation of the new regulations as set forth herein; and

WHEREAS, it is in the best interest of the health, safety and welfare of the citizens to amend the City Code as provided herein.

NOW, THEREFORE, BE IT ORDAINED by the City Council for the City of Le Roy, McLean County, Illinois, as follows:

Section 1. That the chart in Section 1-4-3(B) of the Le Roy Code of Ordinances be and the same is hereby amended by adding the following listed offense and minimum payment amounts:

Improper disposal of landscape waste.

Violation of Section 4-2-2-5.5 E

First Offense: \$500.00

Second Offense: \$600.00

Third and subsequent Offense: \$750.00

Section 2. That Section 4-2-2-5.5 of the Le Roy Code of Ordinances be and the same is hereby amended by adding a new subsection E to read as set forth as follows:

E. No person shall dispose of any landscape waste material at the designated city landscape waste disposal site unless such person is a city of Le Roy utility customer, or a contractor holding a valid permit issued by the city for disposal at the site. Landscape waste material must be combustible. No non-combustible material is allowed.

Section 3. That Section 4-2-2-6 of the Le Roy Code of Ordinances be and the same is hereby amended by adding a new subsection G to read as set forth as follows:

G. Unlawful Disposal of landscape waste material: A person commits the offense of Unlawful Disposal of landscape waste material if (1) the person disposing of landscape waste materials is not a city of Le Roy utility customer, or a contractor holding a valid permit from the city authorizing disposal of landscape waste material at the designated disposal site; or (2) the waste material disposed at the designated landscape waste disposal site is not combustible. The minimum fine for such offense shall be Five Hundred Dollars (\$500.00).

Section 4. Recitals. The foregoing Recitals are incorporated herein and form a part of this Ordinance.

Section 5. Publication. The City Clerk be and is hereby authorized and directed to publish this Ordinance in pamphlet form as provided by law.

Section 6. Severability. In the event any part of this Ordinance shall be found and determined to be invalid by a Court of competent jurisdiction, all valid parts that are severable from this invalid part shall remain in full force and effect.

Section 7. Repealer. All ordinances or parts of ordinances in conflict herein, are

hereby repealed, provided, however, that nothing herein contained shall affect any rights, action, or causes of action, which have accrued to the City of Le Roy, prior to the effective date of this Ordinance.

Section 8. Saving Clause. If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

Section 9. Effective Date. This Ordinance shall be in full force and effect ten (10) days following its publication in pamphlet form as provided by law.


