

RESOLUTION No. 24-12-05-30

**A RESOLUTION OF THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS,
AUTHORIZING THE REIMBURSEMENT OF BUSINESS DISTRICT
PROJECT COSTS
(200 and 202 E. Center Street)**

WHEREAS, the City of Le Roy, McLean County, Illinois (the "*City*"), is a duly organized and validly existing municipality of the State of Illinois pursuant to the 1970 Illinois Constitution and the Illinois Municipal Code, as from time to time amended (65 ILCS 5/1-1-2, *et seq.*); and

WHEREAS, the Mayor and the City Council (the "*Corporate Authorities*"), pursuant to the Business District Development and Redevelopment Law of the State of Illinois, 65 ILCS 5/11-74.3-1 *et seq.*, as from time to time amended (the "*BDD Act*") are empowered to undertake the development and redevelopment of business districts within its municipal limits which are in need of revitalization and to impose a retailer's occupation tax, service occupation tax, and a hotel operators' occupation tax in an amount not to exceed one percent (1%) if such districts are deemed to be "blighted", as defined in the BDD Act; and

WHEREAS, in accordance with the provisions of the BDD Act the City, after properly giving all notices, conducting a public hearing and making all findings required by law, on the 16th day of April, 2020, pursuant to Ordinance No. 20-03-03-30 approved an Eligibility Study and Business District Plan and Project (the "*Business District Plan*"), for an area designated as the City of LeRoy Business District (the "*Business District*"), and imposed a Retailers' Occupation Tax and Service Occupation Tax therein for the planning, execution and implementation of the Business District Plan (the "*BDD Taxes*") and the payment of Business District project costs as set forth in the Business District Plan; and

WHEREAS, the existence of the blighting factors in the Business District, as described in the Business District Plan, and the extraordinary costs necessary for redevelopment have

prevented private developers from developing, redeveloping, and revitalizing the Business District which has, in turn, prevented the development and construction of commercial enterprises within the Business District; and

WHEREAS, Sylvia Clouser, a sole proprietor (the “*Developer*”), owns certain properties within the BD District, commonly known as 200 E. Center St. and 202 E. Center St., and identified by parcel index numbers, 30-21-304-004 and 30-21-304-005, (collectively the “*Subject Properties*”) and has informed the City that she intends to perform various renovations of both of the Subject Properties, including the replacement of the roof; installation of storefront doors and windows; structural improvements including tuck pointing and painting; and, electrical, plumbing and HVAC replacement (collectively the “*Project*”), as delineated in *Exhibit A* to this Resolution for each of the Subject Properties; and

WHEREAS, the Developer informed the City that the ability to undertake the Project on the Subject Properties requires financial assistance from the City for certain costs incurred in connection with the Project, which costs would constitute “Business District Project Costs” (“*BDD Costs*”), as defined by the BDD Act; and

WHEREAS, the Project is consistent with the Business District Plan and the Subject Properties are located within the Business District; and

WHEREAS, the Corporate Authorities have determined that in order to induce the Developer to undertake the Project at the Subject Properties, it is in the best interests of the City, and the health, safety, morals, and welfare of the residents of the City, for the City to reimburse the Developer for certain eligible Business District Project Costs in accordance with the terms and conditions as hereinafter set forth.

NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:

Section 1. That the above recitals are incorporated and made a part of this Resolution.

Section 2. That the reimbursement to the Developer of an amount equal to one hundred percent (100%) of the costs incurred in connection with the Project, is hereby approved, subject to the following:

- A. That each of the costs qualify as eligible BDD Costs; and
- B. That the Developer submits paid invoices or other evidence of payment of each of the BDD Costs to be reimbursed; and
- C. That the amounts to be reimbursed shall not exceed \$193,303 for the 200 E Center Street property and \$191,993 for the 202 E. Center Street property.

Section 4. That this Resolution shall be in full force and effect from and after its passage and approval as provided by law.




