ORDINANCE NO. 25-05-02-42

**AN ORDINANCE IMPOSING A WATER 2020-2021
ALTERNATE REVENUE BONDS FEE AND ELIMINATING
THE WATER CAPITAL PROJECTS FEE**

WHEREAS, the City of LeRoy, McLean County, Illinois is an Illinois municipal corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq.* (hereinafter referred to as "CITY"); and

WHEREAS, the Mayor and City Council of the City of Le Roy have determined that it is necessary and beneficial for the citizens of the City of Le Roy to have access to clean water and efficient, effective removal and treatment of wastewater; and

WHEREAS, the Mayor and City Council of the City of Le Roy have previously issued 2020-2021 Alternate Revenue Bonds to pay for necessary improvements to the City of LeRoy water system; and

WHEREAS, it is necessary to impose a fee to establish a revenue source to pay for such bonds; and

WHEREAS, the \$8.00 flat fee for Water Capital Projects previously imposed by the LeRoy Code of Ordinances is no longer necessary and should be eliminated:

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE COUNCIL OF THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS, as follows:

Section 1. Elimination of Water Capital Bond Project Fee: That Section 8-1-7 (E), establishing a Water Capital Bond Project Fee, is hereby repealed. Nothing in this Ordinance

shall be construed as eliminating the requirement to pay any fees incurred prior to the date of the repeal of Section 8-1-7 (E) (Water Capital Bond Project Fee) of the City of LeRoy Code of Ordinances.

Section 2. Enactment of Water 2020/2021 Alternate Revenue Bond Payment Fee.

Section 8-1-7 of the City of Le Roy Code of Ordinances is hereby amended to add a new Subsection E, entitled "2020/2021 Alternate Bond Payment Fee," as follows:

E. Water 2020/2021 Alternate Bond Payment Fee. All water customers of the City of LeRoy will be required to pay three dollars and thirty-five cents (\$3.35) as a water charge per every one thousand gallons of water used to pay for 2020/2021 Alternate Revenue Bonds.

Section 3. Repealer. All ordinances, resolutions, or orders, or parts thereof, in conflict with the provisions of this Ordinance are to the extent of such conflict hereby repealed.

Section 4. Publication. The City Clerk, be and he is hereby authorized and directed to publish this ordinance in pamphlet form as provided by law.

Section 5. Effective Date. This ordinance shall be effective from and after its passage, approval and publication.
