ORDINANCE NO. 25-05-01-80

**AN ORDINANCE PROVIDING FOR AND APPROVING THE SALE OF
PERSONAL PROPERTY OF THE CITY OF LE ROY, McLEAN COUNTY,
ILLINOIS**

WHEREAS, the City of Le Roy, being organized under the laws of the State of Illinois and having less than 500,000 population, owns personal property which in the opinion of a simple majority of the corporate authorities now holding office is no longer necessary or useful to, or for, the best interests of said City; and

WHEREAS, the City of Le Roy has authority under the Illinois Municipal Code 65 ILCS 5/11-76-4 and the City of Le Roy Code Section 7-6-3; and

WHEREAS, a majority of the corporate authorities now holding office at a regular meeting held at 7:00 p.m., on May 5, 2025, did make and aforesaid determination;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled;

Section 1. The City currently owns a 2014 Ford Taurus, with vehicle identification # 1FAHP2MK8EG145376, which is no longer necessary or useful to the City and such vehicle is hereby declared surplus property.

Section 2. The City Administrator is hereby authorized to dispose of the said vehicle, 2014 Ford Taurus in a legal manner deemed to be in the best interest of the City of Le Roy, pursuant to the authority within 7-6-3.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.




