**REVISION OF SECTION 3-6-2
REGARDING REGISTRATION FEES
FOR SOLICITORS**

WHEREAS, the City Council has not reviewed the registration fees for persons desiring to solicit in the City of LeRoy for several years;

WHEREAS, it is in the best interests of the citizens of the City of LeRoy to raise the registration fees for persons desiring to solicit in the City of LeRoy; and

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS, as follows:

Section 1. That Chapter 3-6 (Peddlers, Solicitors and Transient Merchants) of the City Code of Ordinances be and the same is hereby amended by amending Section 3-6-2 (D)(1) (Certificate of Registration) as follows (additions are indicated by underlines; deletions are indicated by strikeouts):

1. Fees Established: A fee shall be paid at the time of filing the application, as follows:

Certificate Requested	Fee
*Application/Registration Fee per group (1 st person in group)	<u>\$100.00</u>
*1 st day per person	<u>\$50.00</u>
*2 nd day per person up to 1 week and not more than 1 week	<u>\$25.00</u>

Section 2. Severability. If any section, paragraph, clause or provision of this Ordinance is held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

Section 3. Repealer. All ordinances, resolutions or orders, or parts thereof, which conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.
