ORDINANCE NO. 135

AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975 CHAPTER 21, ZONING CODE, SECTION 21.17 (d) ADMINISTRATION AND ENFORCEMENT -BUILDING PERMIT

BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, Illinois:

Section I. That Chapter 21, Section 21.17 (d) of the Municipal Code, Le Roy, Illinois, as amended, is hereby further amended by adding the following language at the end of the present language in sub-section (d): "Substantial construction or erection of any building or structure must be "Substantial construction or erection of any building permit."

Section 2. That this Ordinance shall be in full force and effect from and after its passage, approval, and publication, as required by law.
