ORDINANCE NO. 360

AN ORDINANCE AMENDING THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 1975  
(AS AMENDED), CHAPTER 21 ZONING, SECTION 21.17(d)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City of LeRoy and of its residents that fees for building permits be increased from the current fee structure,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Section 21.17(d), Building Permit, of Chapter 21, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by deleting the third sentence thereof, beginning "All applications for Building Permits shall be accompanied . . ." and insertion of the following words and numbers in place thereof:

"All applications for Building Permits shall be accompanied by a fee, said fee to be determined as follows:

<u>Projected Cost of Property Improvement or Construction</u>	<u>Building Permit Fee</u>
\$0.00 - \$500.00	\$10.00
\$500.01 - \$1,000.00	\$20.00
\$1,000.01 - \$5,000.00	\$30.00
\$5,000.01 and over	\$75.00.

Section 2. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.




