ORDINANCE NO. 363

AN ADMENDMENT TO ORDINANCE NO. 356

BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, and Illinois Municipal Corporation, in lawful meeting assembled as follows:

Section I. That Ordinance No. 356, Creating New Chapter 20-Building, be amended by amending Section 20.02 by deleting the second line of paragraph begining, "No fence constructed or erected in the City of Le Roy,..." and insertion of the following line in place there of:

to be used as a fence, shall be more than six (6) feet in height unless

Section II. This ordinance shall be in full force and effect ten days after its passage, approval and publication in pamphlet form as required by law.




