ORDINANCE NO. 25-08-02-50

**AMENDMENT OF SECTION 1-4-3
REGARDING FINES FOR
SOLICITING WITHOUT A PERMIT**

WHEREAS, the City Code does not currently contain a provision for settlement of ordinance charges involving solicitation without a permit; and

WHEREAS, it is in the best interests of the citizens of the City of LeRoy to set forth the amounts for payment of citations issued for soliciting without a permit;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS, as follows:

Section 1. That Chapter 1-4-3 (Settlement of Certain Ordinance Violation Charges) of the City Code of Ordinances be and the same is hereby amended by adding to said section in the proper numerical and alphabetical order the following language:

Offenses	Code Section	1st Offense	2nd Offense	3rd Offense
Violation of Solicitation	Chapter 3-6	\$100.00	\$200.00	\$300.00
		(per person)	(per person)	(per person)

Section 2. That Section 3-6-7 (A) of the LeRoy City Code be amended by adding the following sentence to the end of said Section:

In lieu of a court appearance, citations issued for violations of this Chapter may be settled by paying the amounts set forth in Section 1-4-3 of this Code.

Section 3. Severability. If any section, paragraph, clause or provision of this Ordinance is held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

Section 4. Repealer. All ordinances, resolutions or orders, or parts thereof, which conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.




**AMENDMENT OF SECTION 1-4-3 REGARDING FINES FOR
