

ORDINANCE NO. 25-09-01-70

**AN ORDINANCE AMENDING CHAPTER 6-2-10
OF THE CITY OF LE ROY CODE OF ORDINANCES**

WHEREAS, the City of Le Roy has, pursuant to Illinois law, enacted an Ordinance assessing a fee for the privilege of operating a qualified golf cart within the City limits of Le Roy; and

WHEREAS, the City of Le Roy currently imposes a fee of

- A. \$120.00 for a permit to operate a golf cart (Current)
- B. \$50.00 (No proration), In effect January 1, 2025.
- C. \$25.00 – Veterans, Disabled or 65 years or older. (No proration). In effect January 1, 2025.

; and

WHEREAS, it is in the best interests of the health, safety and welfare of the citizens of Le Roy that the fee for operating a qualified golf cart within the city limits of Le Roy be \$___

NOW, THEREFORE, BE IT RESOLVED by the City Council for the City of Le Roy, McLean County, Illinois, as follows:

Section 1. That Chapter 6-2-10 (D) (1) and 6-2-10-(C) (2) of the Le Roy Code of Ordinances be and the same is hereby amended to read as set forth as follows (insertions are indicated by underlines; deletions are indicated by strikeouts):

C. Requirements: All persons wishing to operate a golf cart and other non-highway vehicles on the City streets must ensure compliance with the following requirements:

2. Must be certified with the City and have the vehicle(s):

- A. ...certified with the City by inspection by a certified mechanic (Current).
- B. ...schedule an inspection at City Hall, (annually or upon exchange of vehicle). In effect January 1, 2025.

D. Permits:

1. No person shall operate a qualified golf cart or other non-highway vehicle without first obtaining a permit from the City Clerk as provided herein. Permits shall be granted for a period of one year and renewed annually. The cost of the permit is:

A. \$120. (current).

B. \$50.00 (No proration). In effect January 1, 2025.

C. \$25.00 (Veterans, disabled or 65 years or older. (No proration). In effect January 1, 2025.

Insurance coverage is to be verified and to be in effect by the Police Department when obtaining and renewing a permit.

Section 2. Recitals. The foregoing Recitals are incorporated herein and form a part of this Ordinance.

Section 3. Publication. The City Clerk be and is hereby authorized and directed to publish this Ordinance in pamphlet form as provided by law.

Section 4. Severability. In the event any part of this Ordinance shall be found and determined to be invalid by a Court of competent jurisdiction, all valid parts that are severable from this invalid part shall remain in full force and effect.

Section 5. Repealer. All ordinances or parts of ordinances in conflict herein, are hereby repealed, provided, however, that nothing herein contained shall affect any rights, action, or causes of action, which have accrued to the City of Le Roy, prior to the effective date of this Ordinance.

Section 6. Effective Date. This Ordinance shall be in full force and effect ten (10) days following its publication in pamphlet form as provided by law.
