Resolution No. 25-10-01-90

A Resolution Approving and Authorizing Financial Commitment in the Safe Routes to Schools Grant Program

WHEREAS, in the interest in promoting safe and healthy active transportation to schools, the City of Le Roy (“**City**”) and LeRoy CUSD #2 (“**District**”) , have partnered to complete a Safe Routes to Schools Infrastructure project; and

WHEREAS, it is in the best interest of both the City and the District to implement infrastructure improvements, conduct educational and encouragement programs for the health and benefit of school children, and improve safe travel to and from schools; and

WHEREAS, the City Council wishes to support IDOT’s “Safe Routes to Schools” program (“**Program**”) and is committed to provide the necessary support and funds in the event that the City receives grant funding to reimburse the City’s investment; and

WHEREAS, the City intends to install certain infrastructure improvements along school walk routes and crossings (“**Improvements**”) as recommended by City leadership, staff and the District; and

WHEREAS, the improvements are eligible for reimbursement under the Program; and

WHEREAS, the City has available funds in the General Fund to finance the improvements until reimbursed by the Program, and the financial capability to maintain the Improvements in a safe and attractive manner for public use; and

WHEREAS, the President and the City Council have considered the City’s participation in the Safe Routes to Schools Grant Program and determined that it is in the best interests of the City and its residents to enter into the program for the benefit of the project; **and**

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF LE ROY, COUNTY OF MCLEAN, STATE OF ILLINOIS, as follows:

SECTION ONE: RECITALS. The foregoing recitals are incorporated in, and made a part of, this Resolution by this reference as findings of the City Council of the City of Le Roy.

SECTION TWO: APPROVAL. The City’s participation in the Illinois Safe Routes to Schools Program and financial commitment to install and maintain the eligible Improvements is hereby approved.

SECTION THREE: EFFECTIVE DATE. This resolution shall be in full force and effect from and after its passage and approval in the manner provided by law.






