

2025 Emergency Business Grant Program

PURPOSE:

The purpose of the City of Le Roy 2025 Local Business Grant Program is to support recovery of the local business community and Le Roy citizens who have lost their SNAP benefits due to a shutdown of the Federal Government.

ELIGIBILITY:

- Only local businesses operating as a grocery store within the borders of the City of Le Roy Illinois and reporting sales tax to the Illinois Department of Revenue to the City of Le Roy Location Code are eligible to participate in this grant program.
- City of Le Roy business location must be operating as of November 1st, 2025, and have been in operation in at least a portion of calendar year 2025.
- A Voucher applicant *must be a resident of the City of Le Roy for at least six months* prior to application.
- A Voucher applicant must have been a SNAP beneficiary (recipient) in October 2025.
- A Voucher applicant must be eligible to receive SNAP benefits at the time of application.

GRANT/VOUCHER PROCESS AMOUNT AND AWARD:

- *Any resident eligible to participate in this program may make applications to the City of Le Roy to receive a voucher for groceries used at an eligible grocery store within the City of Le Roy.*
- *The City of Le Roy administrator is authorized to develop rules, forms, and regulations to implement this program.*
- *A voucher applicant must submit an application form, evidence showing they are City of Le Roy residents and are eligible SNAP beneficiaries as described above.*
- *Applications must be submitted no later than November 13, 2025, and December 11, 2025.*
- *The City will review applications and related materials and determine the amount of any food voucher to be used at a grocery store in the City of Le Roy.*
- *If the applicant meets the eligibility requirements the city will issue a voucher letter stating the amount of funding available under the voucher.*
- *Voucher letters have no value unless redeemed at an eligible grocery store.*
- *Voucher letters may not be sold or transferred.*
- *Vouchers will only be available for 1-2 people in a household at \$125.00 and, \$275.00 for 3 or more people in a household.*
- *Vouchers will only be available in November /December or while the federal government is closed and full SNAP Funding has not been restored or, while funding last.*
- *Vouchers will only be valid in November/December 2025 and therefore must be used prior to January 1, 2026, when they will become null & void.*
- *Applicants must submit proof of a valid SNAP card valid through October and residency within the City of Le Roy corporate boundary to qualify for a City Voucher.*

TERMS AND CONDITIONS

- The Grant Program shall be administered at the sole discretion of the City and nothing in this program creates a right to any business or person to receive any funds or creates an obligation of the City to expend any funds. All Grants by the City are expressly conditioned upon the satisfactory completion of an Application and adherence to these Grant Program Administrative Rules.
- The Grant Program Application must be completed and submitted to the City.
- Not Transferable. If a Grant is approved, it will be awarded via a voucher letter in the name of the Applicant submitted on the Application. Grant awards are not transferable to another person, owner, entity, or business.
- All payments under the Grant Program will be made public and will contain the amount of the Grant funds redeemed to the business and the business' name and information. Applicants, upon submission of an Application, release the City from any and all liability, waive any rights in regard to the proprietary information's confidentiality, and covenant not to sue the City for the release of said proprietary information and from any other claim arising from this Application and the Grant Program. City, for this section, shall mean its elected officials' officers, employees, agents, affiliates, and representatives. Submission of an Application is an express consent and agreement to the above.




