**ORDINANCE NO. 26-05-01-70**

**AN ORDINANCE APPROVING A COLLECTIVE BARGAINING AGREEMENT WITH ILLINOIS COUNCIL OF POLICE**

**WHEREAS**, the City of LeRoy has concluded negotiations with the Illinois Council of Police for a collective bargaining agreement commencing May 1, 2026 and terminating April 30, 2029; and

**WHEREAS**, the City of LeRoy desires to approve said agreement; and

**WHEREAS**, the City has authority, pursuant to the Illinois Public Labor Relations Act to enter into collective bargaining agreements with its police employees; and

**WHEREAS**, it is in the best interests of the health, safety and welfare of the citizens of LeRoy to approve the collective bargaining agreement with Illinois Council of Police.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council for the City of LeRoy, McLean County, Illinois, as follows:

**Section 1.** That the Collective Bargaining Agreement attached hereto as Exhibit A with the Illinois Council of Police for the term May 1, 2023 through April 30, 2029 is approved and the mayor is authorized to execute said agreement and file the same with the Illinois State Labor Board as required by law.

**Section 2. Recitals.** The foregoing Recitals are incorporated herein and form a part of this Ordinance.

**Section 3. Publication.** The City Clerk be and is hereby authorized and directed to publish this Ordinance in pamphlet form as provided by law.

**Section 4. Severability.** In the event any part of this Ordinance shall be found and determined to be invalid by a Court of competent jurisdiction, all valid parts that are severable

from this invalid part shall remain in full force and effect.

**Section 5. Repealer.** All ordinances or parts of ordinances in conflict herein, are hereby repealed, provided, however, that nothing herein contained shall affect any rights, action, or causes of action, which have accrued to the City of LeRoy, prior to the effective date of this Ordinance.
