

**ORDINANCE NO. 01-05-10-40**

**AN ORDINANCE AMENDING CHAPTER 8, GARBAGE, SECTION 8.06, MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 1975 (as amended)**

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is necessary and in the best interest of the City and its residents that the rates for refuse collection services provided by the City be increased, said increase to be effective June 1, 2001,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That sub-sections a., b. and c., of Section 8.06 REFUSE FEES FOR A CALENDAR MONTH FOR EACH CLASSIFICATION OF REFUSE COLLECTION CUSTOMERS, Chapter 8, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), are hereby deleted.

Section 2. New sub-section a., and b., of Section 8.06 REFUSE FEES FOR A CALENDAR MONTH FOR EACH CLASSIFICATION OF REFUSE COLLECTION CUSTOMERS, of Chapter 8, GARBAGE, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), are hereby adopted in words and figures as follows:

b. Multi-Family Dwellings, being a residential building, complex of residential building, or a mobile home park, containing 2 or more separate dwelling units, shall be billed per unit even if one or more dumpsters are used for the convenience of the landlord, tenants, or both.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.


