

**ORDINANCE NO. 06-10-02-40**

**AN ORDINANCE AMENDING TITLE FOUR, GARBAGE AND REFUSE,**

**SECTION 2-2-4, MUNICIPAL**

**CODE OF THE CITY OF LE ROY, ILLINOIS, 2003 (as amended)**

**WHEREAS**, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is necessary and in the best interest of the City and its residents that the rates for refuse collection services provided by the City be increased, said increase to be effective November 1, 2006,

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

Section 1. That Section 2-2-4 RATES, of Title 8, GARBAGE AND REFUSE of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), are hereby deleted.

Section 2. New Section 2-2-4 RATES, of Title 8, GARBAGE AND REFUSE of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), are hereby adopted in words and figures as follows:

a. Multi-Family Dwellings, being a residential building, complex of residential building, or a mobile home park, containing 2 or more separate dwelling units, shall be billed per unit even if one or more dumpsters are used for the convenience of the landlord, tenants, or both. (Ord. 01-05-10-40, 5-21-2001)




