ORDINANCE NO. 601

AN ORDINANCE AMENDING CHAPTER 8, GARBAGE, SECTION 8.06, MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (as amended)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is necessary and in the best interest of the City and its residents that the rates for refuse collection services provided by the City be increased, said increase to be effective June 1, 1995,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That sub-sections a., b. and c., of Section 8.06 REFUSE FEES FOR A CALENDAR MONTH FOR EACH CLASSIFICATION OF REFUSE COLLECTION CUSTOMERS, Chapter 8, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), are hereby deleted.

Section 2. New sub-sections a., b. and c., of Section 8.06 REFUSE FEES FOR A CALENDAR MONTH FOR EACH CLASSIFICATION OF REFUSE COLLECTION CUSTOMERS, of Chapter 8, GARBAGE, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), are hereby adopted in words and figures as follows:

a. Fees for Regular Collection from Residential Premises and Commercial Premises Treated as Residential Premises.

One Family Residence	\$ 7.00 per month
Two Family Residence	\$14.00 per month
Commercial Establishments	\$ 7.00 per month
Multi-Family Dwelling	\$ 7.00 per month per unit

b. Monthly Fees for Commercial and Business Establishments, and Other Institutions and Non-residential Refuse Collection Customers.

**NOTE:** A commercial or business establishment qualifying for treatment as a residential unit may enter into an agreement with the landlord of the premises or an adjacent business, or the landlord of an adjacent premises, to place the trash and refuse from the first commercial or business establishment in a dumpster maintained by the landlord of the premises in which the commercial establishment or business is located, or maintained by an adjacent business or the landlord of an adjacent property, but in all other respects the commercial or business establishment will still be billed as a separate unit and may not exceed the limit of trash or refuse of five trash cans to be picked up once a week.

c. Multi-Family Dwellings, being a residential building, complex of residential building, or a mobile home park, containing 2 or more separate dwelling units, shall be billed per unit even if one or more dumpsters are used for the convenience of the landlord, tenants, or both.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.






