ORDINANCE NO. 264

AN ORDINANCE AMENDING THE MUNICIPAL CODE OF LeROY, ILLINOIS 1975 (as amended) CHAPTER 32 BUSINESS REGULATIONS.

WHEREAS, the Mayor and the City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its citizens to encourage wholesome and worthwhile activities for the youth of the community, and

WHEREAS, the Mayor and the City Council of the City of LeRoy, have determined that various charitable community-oriented organizations are providing or would be able to provide such activities for the youth of the community, and

WHEREAS, in order to encourage and promote such activities the City Council finds that waiver of the license fee required for shows, amusements, public dancing, and amusement devices, is appropriate in order to encourage the aforesaid activities for the aforesaid purposes,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled as follows:

Section 1: That a new Section 32.05½ is hereby adopted in words and figures as follows:

The license fees required under this Chapter for public dancing (Section 32.03), shows and amusements (Section 32.04), and amusement devices (Section 32.05), is hereby waived upon proper application for any charitable or other not-for-profit organization having either as a principal objective or as the substantial part of its normal activities the encouraging of wholesome and worthwhile activities for the youth of the community and the providing of places of assembly for such activities for the youth of the community. Application shall be in writing, shall include the name of the organization, the address of its principal place of business, the address of the location of the licensed activity if that is other than at its principal place of business, the name, address and telephone number of its principal officer, the name, address and telephone number of any other person who should be contacted for further information in regard to the application, a statement of the activity it will be engaging in or does engage in that is licensed and a statement establishing the justification for a waiver as permitted under this Section, and any other reasonable information

that the City Council may determine to be appropriate in order to make a final decision as to the waiver of the license fee under this Section. The license will still be required in accordance with this Chapter but the license fee may be waived as set forth previously herein. At such times as the City Council determines that the charitable organization or other not-for-profit organization has ceased using the amusement device, show or amusement, or public dancing for its primary objective of encouraging wholesome and worthwhile activities for the youth of the community, the City Council shall cause written notice to be given to the organization advising it that if proof is not given of the continued activity for which the waiver of the license fee was allowed, within thirty days from the date of delivery of the notice to the organization, that the license fee shall be reimposed, in accordance with the Municipal Code of LeRoy, Illinois of 1975 (as amended).

Section 2. That this ordinance shall be in full force and effect from and after its passage and approval in pamphlet form as required by law.

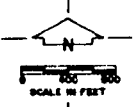
