

ORDINANCE NO. 483

**ORDER APPROVING ACCEPTANCE OF BID  
OF AL WIEGAND, INC., AND  
EXECUTION OF CONTRACT BY APPROPRIATE CITY OFFICIALS**

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, find it is necessary for the City to enter into a public works project as described in Exhibit "A" attached hereto, and

WHEREAS, in so doing it will be necessary to enter into a contract as set forth in Exhibit "A," attached hereto, which contract shall require a significant expenditure of funds by the City,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

**Section 1.** The bid set forth in Exhibit "A," attached hereto and incorporated herein by reference, is accepted effective January 4, 1993, and the contract, set forth in Exhibit "A," attached hereto and incorporated herein by reference, is hereby approved.

**Section 2.** The Mayor and City Clerk of the City of LeRoy are hereby directed to execute the contract, attached hereto as Exhibit "A," in the original and as many copies as may reasonably be required, retaining a signed copy of the contract for the City, after it has been executed by all parties, said officers being deemed, by executing the aforesaid contract, to have evidenced the ratification of the bid acceptance effective January 4, 1993, in accordance with the vote of the City Council on that date approving the acceptance of said bid.

**Section 3.** This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as required by law.

WITNESSETH: That for and in consideration of the payments and agreements hereinafter mentioned:

1. The CONTRACTOR will commence and complete the construction of Golden Eagle Sanitary Sewer - Phase I
2. The CONTRACTOR will furnish all of the material, supplies, tools, equipment, labor and other services necessary for the construction and completion of the PROJECT described herein.
