ORDINANCE NO. 157

AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975, CHAPTER 34, LIQUOR, SECTION 34.03K.

BE IT ORDAINED by the Mayor and City Council of the City of LeRoy in lawful meeting assembled as follows:

Section 1: That Section 34.03K is hereby amended by adding the following words after the words "United States citizenship" and before the comma immediately succeeding the word "citizenship":

"or residency in the city".

Section 2: That Section 34.09B(4) is hereby amended by changing the hours set forth in the last line of said subsection from "1:00 p.m. and 10:00 p.m. on Sundays" to "12:00 p.m. and 10:00 p.m. on Sundays."

Section 3: This ordinance shall be in full force and effect after its passage, approval, and publication in pamphlet form as required by law and by the ordinances of the City of LeRoy.

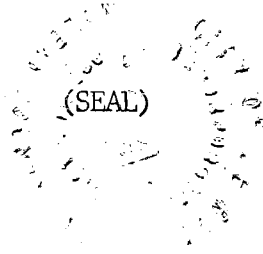
I, Juanita Dagley, certify that I am the duly elected and acting municipal clerk of the City of Le Roy, McLean County, Illinois.
