AN ORDINANCE AMENDING CHAPTER 34 LIQUOR, SECTION 34.09 B (2) and (3), MUNICIPAL CODE OF LEROY, ILLINOIS 1975 (as amended).

Whereas, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that amendment of certain of the liquor license classifications as set forth in Chapter 34 of the Municipal Code of LeRoy, Illinois, is appropriate, and in the best interests of the City and of its residents,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1. That Section 34.09 B (2), of Chapter 34 Liquor, Municipal Code of LeRoy, Illinois 1975 (as amended), is hereby amended by inclusion of the words "and wine" in the first line of said subsection after the words "sale of beer".

Section 2. That Section 34.09 B (3), of Chapter 34 Liquor, Municipal Code of LeRoy, Illinois 1975 (as amended), is hereby repealed.

Section 3. New Section 34.09 B (3), of Chapter 34 Liquor, Municipal Code of LeRoy, Illinois 1975 (as amended), in words as follows is hereby adopted:

"(3). Class C Licenses - shall authorize the retail sale on the premises specified for consumption off the premises of alcoholic liquors as follows:

- a. Retail sale of alcoholic liquor on premises specified for consumption off of the premises - Class C/I license. The annual fee for such license shall be \$500.00.
- b. Retail sale of beer and fortified wine on the premises specified, for consumption off of the premises - Class C/II license. The annual fee for such license shall be \$255.00."

Section 4. That this Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.
