

AN ORDINANCE AMENDING CHAPTER 34, LIQUOR, MUNICIPAL CODE OF LE ROY, ILLINOIS, 1975 (as amended).

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation (hereinafter referred to as "CITY"), have determined that it is in the best interests of the citizens of the City to be given advance notice of liquor license hearings on applications for liquor licenses in accordance with the Municipal Code of LeRoy, Illinois, 1975 (as amended), and

WHEREAS, provision for notice to the public of liquor license hearings is a matter within the province of the decision-making authority of the Liquor Commissioner of the City, and

WHEREAS, it has been determined by the Mayor of City in his capacity as Liquor Commissioner of the City of LeRoy, that public notice should be further provided for under the City ordinances,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Section 34.04, Notice and Hearing on Application of License; Inspection of Premises. A. Notice, Chapter 34, Municipal Code of LeRoy, Illinois 1975 (as amended), is hereby amended by addition of the following language at the end of the existing said sub-section:

Notice shall be given to the public of the time and place for hearing on any application for a liquor license, said notice to be published in a newspaper of local circulation within the City of LeRoy and to be published not less than five days prior to the date of the hearing.

Section 2. That this ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.






