

ORDINANCE NO. 291

AN ORDINANCE AMENDING CHAPTER 34, LIQUOR, SECTION 34.32, HEARINGS, MUNICIPAL CODE OF LE ROY, ILLINOIS, 1975 (AS AMENDED).

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation (hereinafter referred to as "CITY"), have determined that it is in the best interests of the citizens of the City of LeRoy that public notice be given of hearings for violations of Chapter 34, Liquor, of the Municipal Code of LeRoy, Illinois, 1975 (as amended), and

WHEREAS, the Mayor and City Council of the CITY have determined that the presence of a certified court reporter at all hearings is not necessary, since some hearings held by the Liquor Commissioner are for the purpose of granting licenses, and that so long as a record is kept of such hearings that a certified court reporter shall only be required to be present at a hearing on suspension or revocation of a license or other disciplinary measures to be taken as permitted by law,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled as follows:

Section 1. That Section 34.32, Hearings, of Chapter 34, Liquor, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby further amended by addition to the sub-paragraph titled "Hearing Procedures" of new sub-section (E) which is hereby adopted in words and figures as follows:

E. Notice of any hearing shall be given to the license holder and any other interested parties at least five days in advance of the date of the hearing, and shall be given to the public by publication in a newspaper of local circulation within the CITY at least five days in advance of the hearing date. Notice to the public, the license holder and any other interested parties shall include a statement as to the particular section of the Code alleged to have been violated, and shall state the location of the hearing as well as the time and date of the hearing. Notice to the license holder and any other interested parties shall also include a brief statement of the facts supporting the charge as well as a brief statement that the licensee has a right to subpoena witnesses in his or its own behalf, the right to hear witnesses in evidence against him or it, the right for counsel to be present at the hearing, the right to cross examine any witnesses at the hearing, and a right to demand a written specification of charges against him or it in advance of the

hearing. Notice to the public shall not be required to contain the information required to be given to the license holder and any other interested persons other than a statement of the section of the ordinances alleged to have been violated and the time, place and location of the hearing.

Section 2. That Section 34.32, Hearings, of Chapter 34, Liquor, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby further amended under sub-section (C) by addition of the following words at the beginning of said sub-section prior to the words "a certified court reporter...":

When any hearing shall be held in regard to the question of suspending or revoking any license granted in accordance with this Ordinance, or otherwise disciplining a license holder in accordance with the laws of the State of Illinois or the Liquor Control Ordinances of the City of LeRoy, Illinois, "

and by changing the "A" at the beginning of the present sub-section "C" to a lower case "a".

Section 3. This ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as required by law.






