ORDINANCE NO. 643

AN ORDINANCE AMENDING CHAPTER 34, LIQUOR, SECTIONS 34.30 AND 34.09B(4),
OF THE MUNICIPAL CODE OF THE CITY OF LEROY, MCLEAN COUNTY, ILLINOIS,
1975 (as amended)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, find that December 31, 1995, commonly referred to as "New Year's Eve", falls on Sunday of the normal calendar week; and

WHEREAS, the Mayor and City Council of the City of LeRoy have received requests from several holders of city liquor licenses requesting that such holders be permitted to be open for certain hours, or to the extent that they are already permitted to be open certain hours on Sunday, December 31, 1995, or in such instance where a liquor license holder may already be opened on said day, then in such event to permit an extension of the hours beyond the normal closing time as currently provided by ordinance; and

WHEREAS, the Mayor and City Council of the City of LeRoy find that it is in the best interests of the City and its residents that license holders of city liquor licenses be permitted to be open for certain designated hours on Sunday, December 31, 1995, and Monday, January 1, 1996, or to extend the permitted hours during which a license holder can be open,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. Section 34.30, Chapter 34, LIQUOR, of the Municipal Code of the City of LeRoy, McLean County, Illinois, 1975 (as amended), is hereby amended by adding the following language at the end of the existing ordinance provision:

All city liquor license holders normally required to be closed and to withhold the sale or the offer to sell at retail of any alcoholic liquor in the city between the hours of 1:00 a.m. and 7:00 a.m. on any day or between the hours of 1:00 a.m. Sunday and 7:00 a.m. on Monday following, are hereby permitted to sell or offer for sale at retail any alcoholic liquor in the city between the hours of noon on Sunday, December 31, 1995, and 1:00 a.m., Monday, January 1, 1996. During the aforesaid hours it shall not be unlawful to keep open for business or to admit the

public to any premises in or on which alcoholic liquor is sold at retail during the hours within which the sale of liquor is otherwise prohibited.

Section 2. Section 34.09B(4), Chapter 34, LIQUOR, of the Municipal Code of the City of LeRoy, McLean County, Illinois, 1975 (as amended), is hereby amended by adding the following language at the end of the existing ordinance provision:

As to Class D liquor license holders the normal hours during which sales of alcoholic liquor are permitted are hereby extended from noon on Sunday, December 31, 1995, until 1:00 a.m. on Monday, January 1, 1996.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
