AN ORDINANCE TO CORRECT MISNUMBERED EARLIER ORDINANCES.

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have had brought to its attention the fact that two ordinances recently passed by the Mayor and City Council of the City of LeRoy have been numbered "249" and that two ordinances have also been numbered "250", and

WHEREAS, the Mayor and City Council of the City of LeRoy, Illinois, desire that said misnumbering, which was done inadvertently, be corrected for the record,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That that ordinance numbered "249" titled "An Ordinance Approving Adoption Of And Execution Of A Construction Contract For Construction Of The New Water Plant Building - 1985" be hereby numbered "251".

Section 2. That that ordinance numbered "250" titled "An Ordinance Approving The Execution Of A Contract Between The City Of LeRoy, Illinois, And The Project Manager Of The Community Development Action Program Grant under Agreement With The State Of Illinois, By Its Department Of Commerce And Community Affairs, Dated December 10, 1984, For Grant Of Funds To Be Loaned By City Of LeRoy To LeRoy Auto/Truck Plaza Associates Development Project" be hereby numbered "252".

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.






