ORDINANCE NO. 773

AN ORDINANCE APPROVING AN INTERGOVERNMENTAL AGREEMENT FOR ANIMAL CONTROL WITH THE MC LEAN COUNTY BOARD OF HEALTH, SAID AGREEMENT PROVIDING FOR FEES FOR IMPOUNDMENT OF DOGS OR CATS

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is necessary to provide from time to time for a place of impoundment for stray dogs and cats picked-up in the City of LeRoy by animal control officers; and

WHEREAS, the Mayor and City Council have determined that it is in the best interest of the City and its residents to enter into an agreement for calendar year 1998 with the McLean County Board of Health providing for the sheltering of dogs and cats subject to impoundment and setting forth fees to be charged therefore,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

<u>Section 1</u>. The Mayor and City Council approves the Agreement, a copy of which is attached hereto as Exhibit "A", and incorporated herein by reference.

Section 2: The Mayor and City Clerk are hereby directed and authorized to sign the original and as many copies as appropriate of that agreement as set forth in Exhibit "A" attached hereto, being certain to obtain one or more fully signed copies for the records of the city.

<u>Section 3</u>: This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

ANIMAL CONTROL INTERGOVERNMENTAL AGREEMENT

This AGREEMENT made this <u>1st</u> day of <u>January, 1998</u> by and between the McLEAN COUNTY BOARD OF HEALTH, the governing body of the McLean County Health Department located in the town of Normal, Illinois hereinafter called the BOARD OF HEALTH and Leroy, a municipal corporation located in the State of Illinois hereinafter called the MUNICIPALITY.

WHEREAS, there is a need to provide quality shelter for dogs or other animals subject to impoundment as provided by the State Animal Control Act, ordinances enacted by the County of McLean pursuant to said Act, and ordinances of the MUNICIPALITY; and,

WHEREAS, the BOARD OF HEALTH has the capacity to provide such services through allowing access to its Animal Control Center during regularly scheduled business hours; and,

WHEREAS, the MUNICIPALITY wishes to purchase quality shelter for dogs or cats subject to impoundment collected within its jurisdictional boundaries; and,

WHEREAS, the BOARD OF HEALTH wishes to provide such services to the MUNICIPALITY through this Agreement;

IT IS THEREFORE AGREED AS FOLLOWS:

- 1. The parties enter into this Agreement for the period January 1, 1998 through December 31, 1998 as follows:
 - a. The BOARD OF HEALTH agrees to provide access to its Animal Control Center during regularly scheduled business hours to a representative of the MUNICIPALITY.
 - b. The BOARD OF HEALTH agrees to provide shelter to dogs or cats subject to impoundment and placed in impoundment by the MUNICIPALITY.
- 2. The MUNICIPALITY agrees to pay to the BOARD OF HEALTH for such services eighteen dollars (\$18.00) per animal impounded at the County Animal Control Center, upon invoice, beginning January 1, 1998, and continuing throughout the term of this Agreement.
- 3. The BOARD OF HEALTH agrees to assist the MUNICIPALITY in enforcing its municipal ordinances by reporting the names and addresses of all persons reclaiming animals placed in the animal shelter by a Leroy Animal Control Officer or other authorized representative of the MUNICIPALITY.

- 4. The BOARD OF HEALTH agrees to save and hold harmless and defend the MUNICIPALITY from and against all claims and liability for loss, damage, injury, or death arising out of acts, errors, or omissions of the BOARD OF HEALTH, its officers, employees, and agents under or pursuant to this Agreement.
- 5. The BOARD OF HEALTH agrees to procure and maintain a liability insurance policy providing coverage against any and all claims for personal injury or property damage arising out of acts, errors, or omissions of the BOARD OF HEALTH, its officers, employees, or agents under or pursuant to this Agreement.
- 6. This Agreement may be terminated for any of the following reasons:
 - a. At the request of the MUNICIPALITY, upon thirty (30) days written notice.
 - b. At the request of the BOARD OF HEALTH, upon (30) days written notice.
- 7. It is understood that the terms of this Agreement include all of the agreements made by the BOARD OF HEALTH and the MUNICIPALITY without regard to any oral conversations which may have taken place prior to its execution or subsequent thereto, and that any changes shall be made in writing and agreed to by both parties.
- 8. If any provision of this Agreement shall be held invalid or unenforceable, the remainder of this Agreement shall nevertheless remain in full force and effect. If any provision is held invalid or unenforceable with respect to a particular circumstances, it shall nevertheless remain in full force and effect in all other circumstances.
