CREATION AND APPOINTMENT OF OFFICE OF FREEDOM OF INFORMATION OFFICER.

Whereas, the City of LeRoy, an Illinois municipal corporation, McLean County, Illinois, has, by its City Council and Mayor, determined that the office of Freedom of Information Officer must be established. and that that Officer should be given certain authority to act upon requests for information and records maintained by the City, all done in regard to the requirements of an act in relation to access to public records and documents adopted by the State of Illinois, effective July 1, 1984,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, Illinois, in lawful meeting assembled:

Section 1. That there is hereby created the appointive office within the said City government to be known as the "Freedom of Information" Officer.

Section 2. That the duties of said officer shall be to reply to all public and employee requests for records and information, and to comply with all necessary and applicable provisions of the Freedom of Information Act.

Section 3. That the City Clerk is hereby appointed to the office o f Freedom of Information Officer.

Section 4. That this ordinance shall be in full force and effect after its adoption, passage and approval by the Mayor and City Council of the City of LeRoy, Illinois and publication in pamphlet form.
