AN ORDINANCE AMENDING ORDINANCE NO. 321, BEING THE SALARY ORDINANCE OF THE CITY OF LE ROY ADOPTED MAY 2, 1988, HEREBY AMENDING CERTAIN SALARIES SET FORTH THEREIN.

WHEREAS, the Mayor and City Council of the City of Le Roy, Illinois, an Illinois Municipal corporation, have determined that it is the best interests of the citizens of said City that the administration of said City be run in as smooth a manner as possible, and by the people most competent and capable of being elected, appointed, or employed to or in the said City government,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled as follows:

Section 1. That the salary for the City Clerk of the City of Le Roy, Illinois, is hereby increased from Fourteen Thousand Dollars (\$14,000.00) per year to Sixteen Thousand Five Hundred Dollars (\$16,500.00) per year, the salary for Mayor is hereby increased from Three Thousand Dollars (\$3000.00) per year to Three Thousand Five Hundred Dollars (\$3500.00) per year, the salary for Treasurer is hereby increased from Two Thousand Dollars (\$2000.00) per year to Two Thousand Two Hundred Fifty Dollars (\$2250.00) per year and the salary for Alderman is hereby increased from Thirty Five Dollars (\$35.00) per meeting attended to Fifty Dollars (\$50.00) per meeting attended

Section 2. Said increase in salary shall become effective May 1, 1989, and shall be effective only as to said officer upon the officers being newly elected or re-elected to said office.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.


