ORDINANCE NO. 610

AN ORDINANCE AMENDING CHAPTER 3, CITY ADMINISTRATION, MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (as amended), AND ORDINANCE NUMBER 353.

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents that Chapter 3, CITY ADMINISTRATION, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), Section 3.11, Settlement of Certain Ordinance Violation Charges, be amended to allow for settlement of ordinance violations in regard to certain nuisances,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. Chapter 3, CITY ADMINISTRATION, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), Section 3.11, and Section 1 of Ordinance No. 353 of the City of LeRoy, are hereby amended by addition of the following words and figures:

Part 5. Nuisances.

A. Grass, weeds or other growth
