


ORDINANCE NO. 394

BE IT ENACTED by the CITY COUNCIL OF THE CITY OF LE ROY, at the regular meeting held on the 20TH day of MAY, 1991, that the following traffic regulations, stop signs, speed zones and location of traffic signs are hereby established for the CITY OF LE ROY, in addition to any other existing Ordinances dealing with the same subject:

25 MPH speed limit on all streets in Golden Eagle Subdivision

Violations of any of the above regulations by any person shall be a violation of law and shall subject such violator to the penalties described in the City Code for the City of Le Roy, Illinois, Chapter 41.

PASSED BY the Mayor and City Council of the City of Le Roy, Illinois on the 20TH day of MAY, 1991.


