**ORDINANCE NO. 04-07-01-41**

**AN ORDINANCE AMENDING TITLE 8; CHAPTER 5 OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003**

**WHEREAS**, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the fees for Business and License Regulations; and

**WHEREAS**, the Mayor and City Council of the City of Le Roy have determined that several of said fees shall be increased, being in the best interest of the city and its residents; and

**WHEREAS**, all things required by law an ordinance to be done in regard to increasing said fees has been completed;

**NOW, THEREFORE BE IT ORDAINED**, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** That Title 8, Sewer Service Fees and Charges, of the municipal Code of Le Roy, Illinois 2003 Chapter 5, Section 1B is hereby amended by substitution of the figure "\$200.00" in place of "\$100.00."

**SECTION 2.** That Title 8, Sewer Service Fees and Charges, of the municipal Code of Le Roy, Illinois 2003 Chapter 5, Section 1B is hereby amended by substitution of the figure "\$300.00" in place of "\$200.00."

**SECTION 3.** That Title 8, Sewer Service Fees and Charges, of the municipal Code of Le Roy, Illinois 2003 Chapter 5, Section 1B is hereby amended by substitution of the figure "\$500.00" in place of "\$400.00."

**SECTION 4.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.


