

ORDINANCE NO. 10-02-04-41

AN ORDINANCE AMENDING TITLE 8, WATER & SEWER; CHAPTER 5, SEWER SERVICE FEES AND CHARGES; SECTION 2, SEWER SERVICE RATES AND CHARGES; SUBSECTION D, RATES AND CHARGES ESTABLISHED, OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003 (AS AMENDED)

WHEREAS, the City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY" has determined that it is necessary and in the best interests of the CITY and its residents, that the basic user rates for sewage disposal services be increased.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

Section 1. Title 8, Water & Sewer; Chapter 5, Sewer Service Fees and Charges; Section 2, Sewer Service Rates and Charges; Subsection D of the Municipal Code of LeRoy, 2003 (as amended) is hereby repealed.

Section 2. Title 8, Water & Sewer; Chapter 5, Sewer Service Fees and Charges; Section 2, Sewer Service Rates and Charges; Subsection D of the Municipal Code of LeRoy, 2003 (as amended) is hereby amended of follows:

D. Rates And Charges Established:

1. **Minimum Charge and Basic User Rate:** There shall be and there are hereby established a minimum charge and basic user rate for the use of and for service supplied by the wastewater facilities of the city. There shall be a minimum charge of six dollars twenty-five cents (\$6.25) per one month period to all users whose water consumption does not exceed one thousand (1,000) gallons per month. There shall be a basic user rate of six dollars twenty-five cents (\$6.25) per one thousand (1,000) gallons metered or adjusted (as set forth in this section) in excess of one thousand (1,000) gallons per one month period to all users who discharge normal strength wastes to the system effective with the first water meter reading after February 1, 2010.
2. **Minimum Charge and Basic User Rate:** There shall be and there are hereby established a minimum charge and basic user rate for the use of and for service supplied by the wastewater facilities of the city. There shall be a minimum charge of six dollars sixty cents (\$6.60) per one month period to all users whose water consumption does not exceed one thousand (1,000) gallons per month. There shall be a basic user rate of six dollars sixty cents (\$6.60) per one thousand (1,000) gallons metered or adjusted (as set forth in this section) in excess of one thousand (1,000) gallons per one month period to all users who discharge normal strength wastes to the system effective with the first water meter reading after February 1, 2011.

3. **Minimum Charge and Basic User Rate:** There shall be and there are hereby established a minimum charge and basic user rate for the use of and for service supplied by the wastewater facilities of the city. There shall be a minimum charge of seven dollars zero cents (\$7.00) per one month period to all users whose water consumption does not exceed one thousand (1,000) gallons per month. There shall be a basic user rate of seven dollars zero cents (\$7.00) per one thousand (1,000) gallons metered or adjusted (as set forth in this section) in excess of one thousand (1,000) gallons per one month period to all users who discharge normal strength wastes to the system effective with the first water meter reading after February 1, 2012.

4. **Increase In Rates:** Effective February 1, 2013, sewer user fees will be increased based on the "Consumer Price Index All Urban Customers (CPI-U)". Any adjustment will be made effective with the first meter reading after February 1 and will be in effect for one year. The consumer price index inflation rate will be evaluated on an annual basis each February, and adjustments will be made accordingly.
