

ORDINANCE NO. 357

AN ORDINANCE AMENDING CHAPTER 7, SEWERS, MUNICIPAL CODE OF LEROY, 1975 (AS AMENDED), AND AMENDING ORDINANCE NO. 97, PART 3, ARTICLE I, SECTION 3, ADOPTED JUNE 4, 1979.

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is necessary for the best interests of the city and its residents that the basic user rate for sewage disposal service be increased,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1: That Chapter 7 of the Municipal Code of LeRoy, Illinois, 1975, and Ordinance No. 97, Section 3 of Article I, Part 3, adopted June 4, 1979, be amended by deleting the figures "1.91" at the end of the fourth line of said section and by deleting the figures "1.45" in the middle of the seventh line of said section, and substituting therefor, respectively, "2.10" (in place of "1.91") and "1.65" (in place of "1.45").

Section 2: Ordinance Number 305 is hereby repealed.

Section 3: The substituted figures and the rates thereby established shall be effective beginning March 15, 1990.

Section 4: That in all other respects the aforesaid ordinance and section of the Municipal Code of LeRoy shall remain in full force and effect.

Section 5: This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
