ORDINANCE NO. 419

AN ORDINANCE AMENDING CHAPTER 7, SEWERS, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED)

WHEREAS, the City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY," has determined that it is necessary, and in the best interests of the CITY and its residents, that the basic user rates for sewage disposal services be increased, and that the billing statement cycle be changed from bi-monthly to monthly,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That Section 3 of Article I, in Part 3 of Chapter 7 of the Municipal Code of LeRoy, 1975 (as amended), and Ordinance Number 97, Section 3 of Article I, Part 3, are hereby repealed.

Section 2. That Chapter 7, Municipal Code of LeRoy, 1975 (as amended), Part 3, Article I, Section 3, and Ordinance Number 97, Section 3 of Article I of Part 3 thereof, are hereby amended by addition of new Section 3 of Article I of Part 3 of Chapter 7, Municipal Code of LeRoy, Illinois, 1975 (as amended), and of Ordinance Number 97, in words and figures as follows:

Basic user rate: There shall be and there is hereby established a minimum charge and basic user rate for the use of and for service supplied by the wastewater facilities of the CITY. There shall be a minimum charge of \$2.25 per one month period to all users whose water consumption does not exceed 650 gallons per one month period. A total of \$.10 of this minimum charge shall be dedicated for debt service purposes. There shall be a basic user rate of \$2.00 per 1000 gallons metered or adjusted (as set forth in Article I, Section 1) in excess of 650 gallons per one month period to all users who discharge normal strength wastes to the system. A total of \$.16 of this basic user rate shall be dedicated for debt service purposes.

Section 3. Section 4 of Article I of Part 3 of Chapter 7, Municipal Code of LeRoy, 1975 (as amended), and of Ordinance Number 97, is hereby repealed.

Section 4. Chapter 7, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of new Section 4 of Article I, Part 3, Chapter 7, Municipal Code of LeRoy, Illinois 1975 (as amended), in hereby amended in words and figures as follows:

Surcharge rate: For waste strengths above normal strength of 200 mg/BOD and 250 mg/1 SS , a surcharge of \$.29 per pound BOD and \$.10 per pound SS shall be applied. The surcharge for each monthly period shall be computed by the following formula:

SC
$$\text{BOD} = (x-200) \times 0.0000083 \times \$.29$$

SC
$$\text{SS} = (y-250) \times A \times 0.0000083 \times \$.10$$

where

SC
BOD = surcharge above the user rate for BOD concentration above 250 mg/1.

SC
SS = surcharge above the user rate for SS concentration above 250 mg/1.

X = one month average BOD concentration in mg/1.

Y = one month average SS concentration in mg/1/.

A = one month metered water flow adjusted for appropriate losses in gallons.

Section 5. Article II of Part 3, Chapter 7, Municipal Code of LeRoy, Illinois, 1975 (as amended), and of Ordinance Number 97, is hereby repealed.

Section 6. Section 6 of Article III, Part 3, of Chapter 7, Municipal Code of LeRoy, Illinois, 1975 (as amended), and of Ordinance Number 97 is hereby repealed.

Section 7. Article III of Part 3, Chapter 7, Municipal Code of LeRoy, Illinois 1975 (as amended), and of Ordinance Number 97, is hereby amended by addition of new Section 6, in words and figures as follows:

Notice of rates: The users of wastewater treatment services of CITY will be notified annually, in conjunction with a regular bill, of the rate and of the portion of the user charges which are attributable to the wastewater treatment operation, maintenance and replacement.

Section 8. This ordinance shall be in full force and effect December 15, 1991 and after its passage and publication in pamphlet form as required by law.


