**ORDINANCE NO. 05-05-02-41**

**AN ORDINANCE ADOPTING REGULATIONS OF THE COMBINED SEWER OVERFLOW (CSO) OF THE MUNICIPAL CODE, CITY OF LE ROY, ILLINOIS 2003 (AS AMENDED), TITLE 8, WATER & SEWER, CHAPTER 4, SEWER USE AND SERVICE, SECTION 6, DISCHARGES INTO PUBLIC SYSTEM, SUBSECTION C, RESTRICTED DISCHARGES.**

**WHEREAS**, the City Council of the City of Le Roy, McLean Count, Illinois, an Illinois municipal corporation, hereinafter referred to as "City" has determined that it is necessary and in the best interests of the CITY and its residents, that new regulations for a combined sewer overflow be added.

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

**Section 1.** Chapter 4, Municipal Code of Le Roy, 2003 (as amended), Section 6, Subsection C is hereby amended in words and figures by adding the following:

Paragraph 3: (8-4-6-C-3)

*The City is authorized that impacts on water quality from discharges from the combined sewer overflows that receive non-domestic waste are to be minimized. The City is further authorized to determine which non-domestic wastewater discharges are tributary to any combined sewer overflows and the City may, at its discretion, review and modify these provisions to control pollutants sourced from said combined sewer overflows.*

**Section 2.** This ordinance shall be in full force and effect and after its passage, approval and publication in pamphlet form as required by law.




