**ORDINANCE NO. 07-04-04-10**

**AN ORDINANCE AMENDING TITLE 7; CHAPTER 2; OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003, PUBLIC WAYS AND PROPERTY; EXCAVATIONS**

**WHEREAS**, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the fees for Public Ways and Property Excavations.

**WHEREAS**, the Mayor and City Council of the City of Le Roy have determined that said fees shall be increased, being in the best interest of the city and its residents; and

**WHEREAS**, all things required by law an ordinance to be done in regard to increasing said fees has been completed;

**NOW, THEREFORE BE IT ORDAINED**, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

**SECTION 1.** Title 7, Chapter 2, Section 1 C: 1, Excavations, of the Municipal Code of Le Roy, Illinois 2003 is hereby amended by substitution of the figure "\$250.00" in place of "\$200.00." (Maximum width of street cut permitted shall be 4 feet; payment of an additional fee in the amount of \$7.00 per square foot for the excavation to be made beyond the original 4 foot width across the paved portion of the street shall be required)

**SECTION 2.** Title 7, Chapter 2, Section 1 C: 2, Excavations, of the Municipal Code of Le Roy, Illinois 2003 is hereby amended by substitution of the figure "\$500.00" in place of "\$200.00." (Maximum width of street cut permitted shall be 4 feet; payment of an additional fee in the amount of \$10.00 per square foot for the excavation to be made beyond the original 4 foot width across the paved portion of the street shall be required)

**SECTION 3.** Title 7, Chapter 2, Section 1 C: 3, Excavations, of the Municipal Code of Le Roy, Illinois 2003 is hereby amended by substitution of the figure "\$500.00" in place of "\$350.00." (Maximum width of street cut permitted shall be 4 feet; payment of an additional fee in the amount of \$10.00 per square foot for the excavation to be made beyond the original 4 foot width across the paved portion of the street shall be required)

**SECTION 4.** Title 7, Chapter 2, Section 1 C: 4, Excavations, of the Municipal Code of Le Roy, Illinois 2003 is hereby amended by substitution of the figure "\$750.00" in place of "\$400.00." (Maximum width of street cut permitted shall be 4 feet; payment of an additional fee in the amount of \$15.00 per square foot for the excavation to be made beyond the original 4 foot width across the paved portion of the street shall be required)

**SECTION 5.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.


