**AN ORDINANCE AMENDING CHAPTER 4 - STREETS,
DITCHES AND TREES, BY ADDITION OF NEW SECTIONS 4.16 AND 4.17,
AND AMENDING CHAPTER 8 - GARBAGE, BY ADDITION
OF NEW SECTION 8.07c. (i), MUNICIPAL CODE OF LEROY,
ILLINOIS 1975 (AS AMENDED)**

BE IT ORDAINED by the City Council of the City of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. Chapter 4, STREETS, DITCHES AND TREES, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of new Section 4.16 in words and figures as follows:

4.16 Trees on City Right-of-Way No person or entity shall cut or trim any tree or shrubbery on City right-of-way unless such person or entity shall have been contracted with by the City of LeRoy to do such work, or unless such work shall otherwise be done with the consent of the Public Works Director of the City of LeRoy.

Section 2. Chapter 4, STREETS, DITCHES AND TREES, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of new Section 4.17 in words and figures as follows:

4.17 Removal and Disposal of Trees or Woody Plants cut on Private Property.

- a. The Director of Public Works of the City of LeRoy shall propound written regulations to establish reasonable rules and regulations for the removal of trees or other woody plants or brush on private property when the removal of said tree, trees, woody plants, or brush, may require placement of limbs, cuttings, wood or other debris on City right-of-way for pick-up or other disposition, or when City right-of-way shall be required, in the interests of public safety, to be blocked or barricaded for a period of time to facilitate the removal of one or more trees on private property.

2. Any tree, woody plant or other brush cut or trimmed by a homeowner or tree trimmer or other contractor on or from private property and then placed for pick-up by the City, such placement being required to be on City right-of-way or near a curb, will be removed by the City in the manner most appropriate, including chipping of the tree, woody plant, brush and other disposable plant material, said chipping to be done at the rate of \$25.00 per hour, with a minimum one-half hour charge. Billing for the chipping fee will be included in the water bill or shall be separately billed, as may be appropriate; such billing to be rendered within a reasonable time after the completion of the work by the City.

Section 3. Chapter 8, REFUSE COLLECTION AND DISPOSAL, Municipal Code of LeRoy, Illinois, 1975 (as amended), Section 8.06, Refuse Fees, is hereby amended by addition of new sub-Section c. (i), in words and figures as follows:

8.06 c. (i) Tree branches, brush and shrubbery, although the same may qualify as bulk refuse as previously defined herein, shall be removed for a fee in addition to the normal refuse collection fee set forth in this Section 8.06, including a chipping fee to be charged as set forth in Chapter 4 of this municipal code.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.






