

**ORDINANCE NO. 15-07-01-90**

**AN ORDINANCE AMENDING TITLE SIX (6) CHAPTER THREE (3)  
SECTION ONE (1): PARKING PROHIBITED ON CERTAIN  
STREETS OF THE MUNICIPAL CODE OF THE CITY OF LE ROY,  
ILLINOIS 2003 (as amended)**

WHEREAS, the City of Le Roy, by ordinance, may provide for the prohibition of parking along city streets and ways,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

Section 1. Parking Prohibited On Certain Streets, of Chapter 3 of Title Six of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), is hereby amended by designating on Schedule A (a copy of which is attached hereto, labeled "Schedule A," and incorporated herein by reference) those additional "no parking" zones as indicated on the attached copy of the Schedule A in **bold print**. All other zones shown in small print are existing "no parking" zones, as currently shown on Schedule A prior to the adoption of this ordinance.

Section 2. The attached copy of the aforesaid Schedule A is hereby approved as being the most current copy of said schedule and all no parking zones as stated therein are hereby approved and ordained as being in full force and effect as of this date.

Section 3. Signs shall immediately be erected for the purpose of regulating the aforesaid "No Parking Zone" as previously described in this ordinance. Upon the erection of the aforesaid signs and the completion of publication of this ordinance, the city police department shall begin enforcement of the regulations as set forth in this ordinance.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

## SCHEDULE A

1. In accordance with Section 6-3-1, the following places are designated as NO PARKING ZONES FROM 11:00 PM EACH DAY UNTIL 6:00 AM THE SUCCEEDING DAY:
  - a. Both sides of each street bordering the Le Roy Park District Swimming Pool including both sides of Washington Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; both sides of Pearl Street in the portion of that street located between the North right-of-way line of Washington Street and the South right-of-way line of Warren Street; both sides of Warren Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way of East Street; and both sides of East Street in the portion of that street located between the South right-of-way line of Warren Street and the North right-of-way line of Washington Street;
  - b. All parts of Main Street and Center Street around the city park located in the circle at the intersections of Center Street and Main Street, including the Northerly, Easterly, Southerly and Westerly bounds of the paved portions of said streets around the aforesaid park.
  - c. The entire North side of Maple Street.
2. In accordance with Section 6-3-1, the following place(s) are designated as 15 MINUTE PARKING BETWEEN THE HOURS OF 4:00 P.M. AND 9:00 P.M. MONDAY THROUGH SATURDAY:
  - a. The fourth parking space located on the east side of S. East Street from the intersection of E. Center and S. East Streets
3. In accordance with Section 6-3-1, the following places are designated as NO PARKING ZONES AT ALL TIMES:
  - a. North and South sides of Center Street from the West side of Buck Street to the East side of West Street, all in the City of Le Roy, McLean County, Illinois.
  - b. U.S. Route 150, both sides, from the West city limits to the East city limits.
  - c. North and South sides of East Maple Street from the East side of East Street to the entrance to the City of Le Roy Sewage Treatment Plant.

- d. Easterly and westerly, and northerly and southerly sides of South Hemlock Street, from the intersection of said street with the southerly and westerly right-of-way boundary of Interstate Route 74 with the easterly and westerly right-of-way lines of Hemlock Street, southerly and then easterly to the intersection of the southern extension of Hemlock Street with Chestnut Street after the same crosses over I-74 and connects with the Route 136 spur road, south from the I-74 / Chestnut Street overpass in the City of Le Roy.
- e. All of Sunset Drive west of the northerly and westerly right-of-way line of South Chestnut Street and Sunset Drive the west boundary line of Golden Centre Subdivision east to Chestnut Street.

- g. **NO PARKING EXCEPT HOMEOWNERS/RESIDENTIAL TENANTS** on all parts of West Street from Washington Street to North Street and all parts of North Street from Walnut Street to White Street.

- h. NO PARKING EXCEPT HOMEOWNERS/RESIDENTIAL TENNANTS on both sides of the 800 & 900 blocks of East Pine Street during community events.
  
  - i. NO PARKING ZONES AT ALL TIMES on the East and West sides of South East Street between Sunset Drive and Burcham Drive.
4. In accordance with Section 6-3-1, the following places are designated as NO PARKING ZONES AT ALL TIMES OTHER THAN AS SET FORTH HEREINAFTER:
- a. East side of South Mill Street, south of the south right-of-way line of East Center Street and north of the north right-of-way line of East Pine Street (The aforesaid "No Parking" zone shall be no parking at all times, except for persons attending school during school hours, persons attending school events, and persons attending community events.)
  - a. 100 Block of South Park Avenue =
    - 1. No Parking anytime on either side of the southbound lane.
    - 2. No Parking anytime on either side of the northbound lane.
  - b. 200 Block of South Park Avenue =
    - 1. No Parking anytime on either side of the southbound lane.
    - 2. No Parking anytime on the west side of the northbound lane.
    - 3. No Parking on the east side of the northbound lane during school events or community events at the football complex.
  - c. 300 Block of South Park Avenue =
    - 1. No Parking anytime in boulevard area.
    - 2. No Parking on the east side of the northbound lane during school events or community events at the football complex.
    - 3. No Parking on the west side of the southbound land during school events or community events at the football complex.
    - 4. No Parking on either side from the football field entrance to Vine Street during school events or community events at the football complex
  - d. 900 Block of East Vine Street =
    - 1. No Parking on either side during school events or community events at the football complex.
  - e. 800 Block of East Vine Street =

1. No Parking on either side during school events or community events at the football complex.
- f. 300 Block of South Daniel Street =
  1. No Parking on either side during school events or community events at the football complex.
5. In accordance with Section 6-3-1, the following places are designated as 2 HOUR PARKING ZONES BETWEEN 7:00 A.M. AND 6:00 P.M. MONDAY THROUGH FRIDAY:
  - a. The east and west sides of the 100 Block of South Chestnut Street, except for the southernmost two spaces on the west side of the 100 Block of South Chestnut Street, which will be designated as HOMEOWNER/RESIDENTIAL TENANTS ONLY.
  - b. The North and South side of the 100 Block of East Center Street.
6. In accordance with Section 6-3-1, the following places are designated as NO PARKING ZONES FROM 9:00 P.M. AND 5:00 A.M. THE SUCCEEDING DAY:
  - a. North East Street between E. Washington and E. Warren Streets.
  - b. North Pearl Street between E. Washington and E. Streets.
  - c. North and South sides of East Washington Street between N. Pearl and N. East Streets.
  - d. East Warren Street between N. East and N. Pearl Streets.




