

ORDINANCE NO. 559

AN ORDINANCE AMENDING SECTION 41.07 PARKING PROHIBITED, OF  
CHAPTER 41, TRAFFIC, MUNICIPAL CODE OF LEROY, ILLINOIS,  
1975 (as amended).

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that the areas hereinafter described, all located within the City of LeRoy, Illinois, have become heavily traveled and that permitting parking along the sides of the hereinafter described streets and right-of-way areas is unsafe; and

WHEREAS, the City by ordinance may provide for the prohibition of parking along city streets and ways,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. That Section 41.07 Parking Prohibited, of Chapter 41, Traffic, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended by designating on Schedule A (a copy of which is attached hereto and incorporated herein by reference) those "no parking" zones as indicated on the attached Schedule A.

Section 2. The attached copy of Schedule "A" is hereby approved as being the most current copy of said schedule and all no parking zones as stated therein are hereby approved and ordained as being in full force and effect as of this date if no ordinance has been adopted previously approving said no parking areas.

Section 3. Ordinance Number 21, adopted February 2, 1976, is hereby repealed.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.





SCHEDULE A

1. In accordance with Section 41.07 the following places are designated as no parking zones from 11:00 p.m. each day until 6:00 a.m. the succeeding day:

a. South Mill Street, and the portion of LeRoy Schools' parking lot located on and along said part of Mill Street, in the Block between the South right-of-way line of East Center Street and the North right-of-way line of East Pine Street;

b. Both sides of each street bordering the LeRoy Park District Swimming Pool including both sides of Washington Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; both sides of Pearl Street in the portion of that street located between the North right-of-way line of Washington Street and the South right-of-way line of Warren Street; both sides of Warren Street in the portion of that street located between the East right-of-way line of Pearl Street and the West right-of-way line of East Street; and both sides of East Street in the portion of that street located between the South right-of-way line of Warren Street and the North right-of-way line of Washington Street;

c. All parts of Main Street and Center Street around the city park located in the circle at the intersections of Center Street and Main Street, including the Northerly, Easterly, Southerly, and Westerly bounds of the paved portions of said streets around the aforesaid park.

2. In accordance with Section 41.07, the following places are designated as no parking zones at all times:

a. North and South sides of Center Street from the West side of Buck Street to the East side of West Street, all in the City of LeRoy, McLean County, Illinois.

b. U.S. Route 150, both sides, from the West city limits to the East city limits.




