**AN ORDINANCE AMENDING ORDINANCE NO. 431,  
ESTABLISHING THRU TRUCK ROUTES AND LIMITING  
TRUCK TRAFFIC ON ALL OTHER STREETS AND WAYS  
IN THE CITY OF LEROY, CHAPTER 41, MUNICIPAL  
CODE OF LEROY, ILLINOIS, 1975 (as amended).**

**WHEREAS**, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, adopted Ordinance No. 431, on March 2, 1992, establishing thru truck routes in the city and limiting truck traffic on all other streets and ways in the City of LeRoy; and

**WHEREAS**, the Mayor and City Council of the City of LeRoy have determined that it is in the best interests of the City of LeRoy and its citizens, and for their safety and welfare, that the aforesaid ordinance be amended,

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

**Section 1.** That Section 1(f)(2) of Ordinance No. 431 (the same being codified as Section 41.20(f)(2), Municipal Code of LeRoy, Illinois, 1975 (as amended)) and Section 41.20 (f)(2), Chapter 41, Traffic, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), are hereby amended by deletion of all of the aforesaid sub-subpart of said Section 1 and of said Section 41.20, and by substitution for the aforesaid deleted language of those words and figures as follows:

(2) Commercial Vehicle; every motor vehicle weighing 12,000 pounds or more gross weight, designed, used or maintained primarily for the transportation of property, including every motor vehicle designed and used primarily for drawing other vehicles and not so constructed as to carry a load thereon either independently or as any part of the weight of any vehicle or load so drawn, and including every motor vehicle designed and used primarily for drawing other vehicles and not so constructed as to carry a load other than a part of the weight of the vehicle and load so drawn.

**Section 2.** This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
