ORDINANCE NO. 530

**DESIGNATION
OF PRIMARY SNOW ROUTES**

WHEREAS, by Ordinance number 527, adopted January 17, 1994, the City Council of the City of LeRoy provided for emergency snow routes to be cleared through the City of any traffic after a certain amount of snow accumulated within a given period of time, and,

WHEREAS, by Schedule F, provided for in the aforesaid Ordinance, said schedule being a part of Chapter 41 of the Municipal Code of the City of LeRoy, McLean County, Illinois, 1975 (as amended), snow routes are to be designated as set forth on the aforesaid Schedule F,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

SECTION 1 The following named streets or parts of streets are hereby designated Primary Snow Routes and shall be set forth as "Designated Snow Routes" on Schedule F of Chapter 41, and Chapter 41 shall be considered amended by the addition of said Designated Snow Routes to Schedule F of said chapter:

Center Street from the north and south extension of the west right-of-way line of Walnut Street to the north and south extension of the east right-of-way line of Pearl Street.

Main Street from the east and west extensions of the south right-of-way line of Pine Street to the east and west extensions of the north right-of-way line of Cherry Street.

Chestnut Street from the east and west extension of the north right-of-way line of Cherry Street to the east and west extensions of the south right-of-way line of Cedar Street.

East Street from the east and west extensions of the north right-of-way line of Cherry Street to the east and west extensions of the south right-of-way line of Cedar Street.

Section 4. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
