ORDINANCE NO. 549

**AN ORDINANCE AMENDING CHAPTER 41, TRAFFIC, AND CHAPTER 3, CITY ADMINISTRATION, MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS, 1975 (as amended), and ORDINANCE NO. 353.**

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents that the revisions of the Illinois Vehicle Code be adopted and made a part of the Municipal Code of the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

**Section 1.** Section 41.01 STATE TRAFFIC LAWS ADOPTED., of Chapter 41 Traffic, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby repealed.

**Section 2.** New Section 41.01 of Chapter 41 Traffic, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby adopted in words and figures as follows:

Section 41.01 STATE VEHICLE CODE ADOPTED. (a) The Illinois Vehicle Code, being Chapter 625, Vehicles, Act 5., Illinois Vehicle Code, cited as 625 ILCS 5/1-101, et seq., is hereby adopted and incorporated into this chapter by reference and shall be applicable in the City of LeRoy the same as if each provision of the aforesaid Illinois Vehicle Code were specifically set forth word for word herein, at length. Further, from time to time as the aforesaid Illinois Vehicle Code is amended such amendments shall be considered to be adopted and said vehicle code, as amended, from time to time, shall be deemed to be a part of this municipal code the same as if said amendments were set forth herein from time to time. (b) Any person who violates any provision of the Illinois Vehicle Code, as amended from time to time, and as the same has been adopted as a part of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), within the City of LeRoy shall be subject to the penalties provided for violation of this code.

**Section 3.** Chapter 41.50, Regulation of the Use of Snowmobiles and Provision for Snowmobile Trails and Routes, (a), is hereby repealed.

**Section 4.** New Section 41.50 of Chapter 41 Traffic, the municipal code of the City of LeRoy, Illinois, 1975 (as amended), is hereby adopted in words and figures as follows:

Section 41.50 Regulation of the Use of Snowmobiles and Provision for Snowmobile Trails and Routes, (a) all provisions of the Snowmobile Regulation and Safety Act of the State of Illinois, being Act 40 of Chapter 625 Vehicles, of the Illinois Compiled Statutes, codified as 625 ILCS 40/1-1, et seq., is hereby adopted and incorporated into this chapter by reference and shall be applicable in the City of LeRoy the same as if each provision of the aforesaid Snowmobile Registration and Safety Act were specifically set forth word for word herein, at length. Further, from time to time the

aforesaid Snowmobile Registration and Safety Act is amended such amendments shall be considered to be adopted and said act as amended from time to time, shall be deemed to be a part of this municipal code the same as if said amendments were set forth herein from time to time. Any person who violates any provision of the Snowmobile Registration and Safety Act within the City of LeRoy shall be subject to the penalties provided for violation of this code.

**Section 5.** Chapter 3, City Administration, Municipal Code of LeRoy, Illinois, 1975 ( as amended), Section 3.11 and Section 1 of Ordinance No. 353 of the City of LeRoy are hereby amended by addition of the following words and figures after Part 4. Traffic, sub-part H.:

**Section 6.** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law


