


ORDINANCE NO. 331

BE IT ENACTED by the CITY COUNCIL OF THE CITY OF LE ROY, at the regular meeting held on the 7th day of November, 1988, that the following traffic regulations, stop signs, speed zones and location of traffic signs are hereby established for the CITY OF LE ROY, in addition to any other existing Ordinances dealing with the same subject:

- 1 yield sign on Oak Street at Barnett Street
- 1 yield sign on Oak Street at Mill Street
- 1 - one-way sign on Oak Street at Barnett Street
- 1 - one-way sign on Oak Street at Mill Street

Violations of any of the above regulations by any person shall be a violation of law and shall subject such violator to the penalties described in the City Code for the City of Le Roy, Illinois, Chapter 41.






