

ORDINANCE NO. 411


BE IT ENACTED by the CITY COUNCIL OF THE CITY OF LE ROY, at the regular meeting held on the 4th day of November, 1991, that the following traffic regulations, stop signs, speed zones and location of traffic signs are hereby established for the CITY OF LE ROY, in addition to any other existing Ordinances dealing with the same subject:

One stop sign on West Street at Pine Street -
southbound traffic

Yield signs on Oak Street at Main Street and Chestnut
Street - east and west bound traffic

Violations of any of the above regulations by any person shall be a violation of law and shall subject such violator to the penalties described in the City Code for the City of Le Roy, Illinois, Chapter 41.

PASSED BY the Mayor and City Council of the City of Le Roy, Illinois on the 4th day of November, 1991.






