

ORDINANCE NUMBER 14-10-02-90

AN ORDINANCE CHANGING THE NAME OR ADDRESS OF A PUBLIC STREET(S) WITHIN THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS

WHEREAS, the City of Le Roy, McLean County, Illinois, an Illinois Municipal Corporation, has a partial section of a public roadway beginning at the diagonal section of Salt Creek Road where it turns from straight north-south to angle at a direction to the southwest and then straightens back out to a direct east-west angle, which is where the current E 250 North Road begins. Part of this section of roadway is in the limits of the City of Le Roy and part of it is in the Township jurisdiction. See Exhibit A.

WHEREAS, The City of Le Roy, McLean County, Illinois has been notified by the county GIS Addressing Tech for the ETSB (Emergency Telephone System Board) that approval of this ordinance would give permission to change that section that falls within the City of Le Roy limits from Salt Creek Road to East 250 North Road.

WHEREAS, the Mayor and City Council of the City of Le Roy deem it appropriate to rename the section of public roadway presently referred to as Salt Creek Road to East 250 North Road.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

Section 1. That the name of Salt Creek Road beginning at the diagonal section of Salt Creek Road where it turns from straight north-south to angle at a direction to the southwest and then straightens back out to a direct east-west angle, which is where the current E 250 North Road begins is hereby changed from Salt Creek Road to East 250 North Road.

Section 3. That this ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.




