AN ORDINANCE APPROVING THE FINAL PLAT OF "WILLIAMS ADDITION" TO THE CITY OF LE ROY, ILLINOIS.

WHEREAS, there has been submitted to the City, a final plat of "WILLIAMS ADDITION" to the City of Le Roy, Illinois (Exhibit #1 attached hereto): and

WHEREAS, this subdivision falls under the conditions as set forth under Section 22.10 of the subdivision code.

WHEREAS, there are no street dedications or public improvements required; and

WHEREAS, this final plat conforms to the requirements of all other City ordinances,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS:

1. That the requirements of the submittal of a tentative plat is hereby waived.
2. That the requirement of the submittal of supporting documents concerning subdivision improvements is hereby waived.
3. That the requirement of the furnishing of a completion bond is hereby waived.
4. That the final plat of "WILLIAMS ADDITION" to the City of Le Roy, Illinois as shown on Exhibit 1 attached hereto: is and shall be hereby approved.
5. That this ordinance shall be in full force and effect as of the time of its passage and approval this 20th day of February, 1984.
