ORDINANCE NO. 339

AN ORDINANCE APPROVING THE FINAL PLAT OF SHARI COURT SUBDIVISION

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have heretofore approved the Preliminary Plan (Tentative Plat) of SHARI COURT SUBDIVISION, which plan met all requirements of the Subdivision Code of the City of LeRoy; and

WHEREAS, there has been submitted to the City of LeRoy a Final Plat of SHARI COURT SUBDIVISION (Exhibit 1, attached hereto) which in all respects substantially conforms to the Preliminary Plan previously approved by the Mayor and City Council, and all other requirements of the Subdivision Code of the City of LeRoy having been met,

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That the Final Plat of SHARI COURT SUBDIVISION, as shown in Exhibit 1 attached hereto, and incorporated herein by reference, is hereby approved.

Section 2. That this ordinance shall be in full force and effect after its passage and approval.
